**ORDER NO. B1- 62446 /2010**

As per the GO read above the Government have temporarily appointed nine Sub Judges / Chief Judicial Magistrates in the Kerala Judicial Service as District and Sessions Judges in the Kerala State Higher Judicial Service. Hence, the following orders are issued:

He will hand over charge of his office to the Judge, Family Court, Kottarakkara and take charge as Judge, Family Court, Nedumangad from the Judge, Family Court Thiruvananthapuram.

The Judge, Family Court, Kottarakkara will hold the full additional charge of the Addl.Sessions Judge(Abkari cases), Kottarakkara until further orders.

The Officer at Sl.No.1 to 3 are eligible for Special Pay for extra administrative work @ Rs.1500/- per month in theri new stations. The Officers at Sl.No.4 to 6, 9,10, 15 to 22 & 24 to 26 are eligible for Special Pay for extra administrative work @ Rs.1000/- per month in their new stations. The officers at Sl. No. 27 to 32, 37 , 39 & 41 are eligible for Special Pay for extra administrative work @ Rs.750/- per month in their new stations. The officers at Sl. No. 42 to 46 are eligible for Special Pay for extra administrative work @ Rs.500/- per month in their new Posts.

The officers at Sl.Nos. 5,7 & 31 are not eligible for transfer grant and joining time. The officers at Sl.Nos. 4 & 46 are not eligible for joining time.
